Call to Order

Mayor Thompson called the Legislative Meeting to order at 7:30 p.m.

Pledge of Allegiance

The Pledge of Allegiance was recited, and a moment of silence was observed.

Presentations

North County Composting Project: David (Dave) Brosch, Composting Municipalities Organizing Now (CMON)

Mr. David Brosch provided an overview of Composting Municipalities Organizing Now and the need for a moderate sized composting facility, to augment the County's current facility, for municipalities in the area. Mr. Brosch discussed the proposed program and how it would help to implement the County's recently adopted Climate Action Plan.

CM Lingua asked about the needs for a potential site location and Mr. Brosch discussed the features needed for a site for the composting facility.

Mayor Thompson discussed the yard waste composting facility in College Park and Mr. Brosch stated that College Park was interested in another site that would handle materials other than leaves.

Mayor Thompson asked if there was space available at the Beltsville Agricultural facility and Mr. Brosch discussed his outreach and feedback regarding potential sites.

CM Lingua asked if there was a cost estimate available. Mr. Brosch stated that there was no cost estimate at this time, but he would come back to the Council when there was more information. Mr. Brosch discussed potential cost share and staffing options.

Mayor Thompson stated that the Mayor and Council would like to be informed as the project progressed.

Economic Update: Gentry Jones, Deputy Director of Finance Services

Deputy Director of Finance Services Gentry Jones discussed the economy from a macro standpoint to include federal interest rates, U.S. inflation, U.S. retail sales, U.S. jobless claims, and State of Maryland revenue. Deputy Director Jones discussed the overall impact of federal interest rates, U.S. inflation, U.S. retail sales, U.S. jobless claims, State of Maryland revenue, and the potential impact on the Town's budget.

CM Lingua thanked Deputy Director Jones for the presentation and discussed the impact of slower real estate sales.

CM Faulx thanked Deputy Director Jones and CM Lingua for the presentation.

Mayor Thompson asked about the personal income graph and Deputy Director Jones stated that the graph showed the change year over year.

Mayor Thompson discussed Comptroller Franchot's estimate for state income and the potential impact of revenue related to the legalization of marijuana. Deputy Director Jones stated that he was unsure if the revenue related to the legalization of marijuana was included in the Comptroller's estimates.

<u>Budget Assumptions and Budget Priorities, Guidelines, Challenges, and Opportunities: Gentry Jones, Deputy Director of Finance Services</u>

Deputy Director Jones discussed the Budget Assumptions for the preparation of the FY2024 proposed budget. Deputy Director Jones discussed the eight building blocks that provide structure for the creation of the proposed budget to include 5-year projections, Riverdale Park values, a conservative approach, the Town vision and commitment statements, guiding principles, debt service goals, fund balance goals, and best practices.

Deputy Director Jones discussed the key components of the budget assumptions to include operating revenue, operating expenditures, capital improvement, as well as the variables for each component.

Deputy Director Jones discussed the budget priorities, guidelines, challenges, and opportunities for the FY2024 proposed budget.

CM Smith thanked Deputy Director Jones for the presentation and asked if the Town's approach to debt would change if the interest rates dropped. Deputy Director Jones provided a response. CM Smith stated that he would like to be more involved in the budget preparation process. Town Manager Lestitian discussed the budget process as it related to the Town Charter.

CM Faulx stated that he was interested in examples of public-private partnerships.
