

### DONATION BINS SHALL BE SUBJECT TO THE FOLLOWING LOCATION AND DESIGN REQUIREMENTS:

- (1) DONATION BINS MUST BE KEPT ON A PAVED OR IMPERVIOUS SURFACE;
- (2) DONATION BINS MAY NOT OBSTRUCT PEDESTRIAN OR VEHICULAR TRAFFIC;
- (3) DONATION BINS MAY NOT BE LOCATED IN THE PUBLIC RIGHT-OF-WAY, DRIVE AISLES, FIRE LANES, SIDEWALKS, REQUIRED PARKING SPACES, LANDSCAPE ISLANDS OR BUFFER STRIPS, OR ANY LOCATION THAT MAY CAUSE HAZARDOUS CONDITIONS OR CONSTITUTE A THREAT TO PUBLIC SAFETY;
- (4) NOT MORE THAN ONE DONATION BIN MAY BE LOCATED ON A LOT OR PARCEL OF PROPERTY;
- (5) DONATION BINS MUST BE CONSTRUCTED OF NONCOMBUSTIBLE MATERIAL AND HAVE A SECURELY CLOSING LID; AND
- (6) DONATION BINS SHALL BE CLEARLY MARKED WITH THE FOLLOWING:
  - I. THE NAME AND CONTACT INFORMATION FOR THE OWNER OF THE BIN;
  - II. THE NAME AND CONTACT INFORMATION FOR THE PERSON OR ENTITY RESPONSIBLE FOR THE MAINTENANCE OF THE BIN;
  - III. THE NAMES AND CONTACT INFORMATION FOR THE PERSON OR ENTITY SOLICITING DONATIONS FOR THE BIN, AND AN INDICATION OF TAX-EXEMPT STATUS;
  - IV. A NOTICE STATING THAT NO ITEMS OR MATERIALS SHALL BE LEFT OUTSIDE THE BIN.
- (7) INFORMATION MARKED ON A BIN AS REQUIRED BY THIS MUST BE UPDATED WHEN THE INFORMATION CHANGES.
- (8) A DONATION BIN MAY NOT EXCEED FIVE (5) FEET IN WIDTH BY FIVE (5) FEET IN DEPTH BY SEVEN (7) FEET IN HEIGHT.
- (9) EACH DONATION BIN AND THE LAND UPON WHICH IT IS LOCATED SHALL BE MAINTAINED IN A SAFE AND CLEAN CONDITION. EACH BIN MUST BE REGULARLY EMPTIED OF ITS CONTENTS SO THAT IT DOES NOT OVERFLOW.

### DONATION BINS PERMITS SHALL BE SUBJECT TO THE FOLLOWING ANNUAL FEES:

- (1) \$200 FOR NEW REGISTRATIONS
- (2) \$100 FOR RENEWAL REGISTRATIONS
